

RELEASE OF LIABILITY
READ CAREFULLY - THIS AFFECTS YOUR LEGAL RIGHTS

In exchange for participation in the activity of the practice of Aikido or other workouts organized by The Grove Aikido Club ("G.A.C."), and/or use of the property, facilities and services used by G.A.C., I agree for myself and (if applicable) for the members of my family, to the following:

1.I agree to observe and obey all posted, un-posted, or verbal rules and warnings, and further agree to follow any oral instructions or directions given by G.A.C., members or the employees, representatives or agents of G.A.C., or of the facility where practices or club meetings are held.

1. I recognize that there are certain inherent risks associated with the above described activity and I assume full responsibility for personal injury to myself and (if applicable) my family members, and further release and discharge G.A.C. and the facility where practices or club meetings are held, from responsibility of injury, loss or damage arising out of my, or my family's, use of, or presence upon the facilities of G.A.C., whether caused by the fault of myself, my family, G.A.C. members or other third parties.

1.I agree to indemnify and defend G.A.C. and the facility where practices or club meetings are held, against all claims, causes of action, damages, judgments, costs or expenses, including attorney fees and other litigation costs, which may in any way arise from mine or my family's use of, or presence upon, the facilities where G.A.C. meetings or practices are held.

1.I agree to pay for all damages to any facilities where G.A.C. meetings or practices are held caused by me or my family's negligent, reckless, or willful actions.

1.I consent to the participation of my child /children, named below:

_____ , _____ , in Practice of Aikido, or other workouts, and agree on behalf of the above minor /minors to all of the terms and conditions of this Agreement. By signing this Release of Liability, I represent that I have legal authority over and custody of the above named minors.

1. In the event of an injury to me or the above minor/minors during the above described activities, I give my permission to G.A.C or to the employees, representatives or agents of G.A.C. or to the employees of the facility where practices or club meetings are held, to arrange for all necessary medical treatment, if I am unavailable, or unable, for which I shall be financially responsible. This temporary authority will begin on the date this agreement is signed and will remain in effect until terminated in writing by the undersigned or when the above described activities are no longer engaged in.

G.A.C., or the facility where practices or club meetings are held, shall have the following emergency powers if I am injured, or am unable to aid my child/children, and any or all of these shall be at my expense:

- a. The power to seek emergency medical treatment or attention for me or my child as may be required by the circumstances, including without limitation, that of a licensed medical physician and/or a hospital;
- b. The power to authorize emergency medical treatment or medical procedures in an emergency situation; and
- c. The power to make appropriate decisions regarding clothing, bodily nourishment and comfort in an emergency situation.

Any legal or equitable claim that may arise from participation in the above shall be resolved under local state law.

I HAVE READ THIS DOCUMENT AND UNDERSTAND IT. I FURTHER UNDERSTAND THAT BY SIGNING THIS RELEASE, I VOLUNTARY SURRENDER CERTAIN LEGAL RIGHTS.
